As part of the curriculum, MLF students undertake graduate level courses in the core courses of First Principles of Financial Economics; Finance; and the Law and Economics of Corporate Transactions. These core courses are then supplemented by courses from the Law Faculty and Saïd Business School's wide offering of electives, including Principles of Financial Regulation, Corporate Finance Law, Entrepreneurial Finance Projects, Mergers and Acquisitions, and Investing in Public Equity.
